REGULAR MEETING

I. CALL TO ORDER BY MAYOR BARBER.

II. CONSENT AGENDA:

1. Council Meeting Minutes of October 27, 2015

Councilman Hall requested that item #4 under Progress Reports and Announcements be amended to delete a portion of the last sentence that indicated he had firsthand knowledge of the number of students impacted by the new tardy policy at Christiansburg High School. His voiced concern was based on information he had received from concerned parents.

Councilman Hall made a motion to approve the consent agenda, with the requested amendment to the minutes, seconded by Councilman Vanhoozier. Council voted on the motion as follows: Bishop – Aye; Hall – Aye; Huppert – Aye; Showalter – Aye; Stipes – Aye; Vanhoozier – Aye.

III. RECOGNITIONS:

- a. Resolution supporting Small Business Saturday and declaring November 28, 2015 as "Small Business Saturday". Councilman Vanhoozier made a motion to adopt the resolution, seconded by Councilman Bishop. Council was polled on the motion as follows: Bishop – Aye; Hall – Aye; Huppert – Aye; Showalter – Aye; Stipes – Aye; Vanhoozier – Aye.

IV. CITIZEN'S HEARING:

1. LAURA B. GUILLIAMS, EXECUTIVE DIRECTOR OF NRV CARES, TO ADDRESS COUNCIL. Laura Guilliams thanked Council for the opportunity to speak, and for its continued support of NRV Cares and its community programs. During 2015, the agency has provided services and resources to more than 900 people in Christiansburg through community education and awareness programs, and the CASA volunteer program. Ms. Guilliam expressed her appreciation for the Town's efforts to bring awareness to the problem of child abuse during the child abuse prevention month of April. She provided Council with statistics on child abuse and neglect in Christiansburg and Virginia, noting that support from communities has a big impact on efforts to strengthen families affected by abuse. NRV Cares will continue its tradition of lighting the Tree of Hope in the downtown square, a campaign to raise funds and bring community awareness during the holiday season.
2. COACH PORTER, CHRISTIANSBURG HIGH CROSS COUNTRY COACH, TO ADDRESS COUNCIL. Brian Porter, coach of the Christiansburg High School cross-country team, addressed Council regarding safety concerns along the Huckleberry Trail where his teams train. He explained an incident on the trail in which a man exposed himself to several girls during a recent practice, and has not yet been found. After speaking with several other coaches, and concerned parents, Coach Porter said he decided to come before Council to request it consider placing emergency call boxes and/or security cameras at various locations along the trail to improve the safety of trail users. Council discussed the possibility of utilizing emergency call boxes, similar to those used by Blacksburg, and Mayor

Barber turned the matter over to Town staff and Police Chief Sisson to study and provide a recommendation to Council.

VI. DISCUSSIONS BY MAYOR AND COUNCIL MEMBERS:

1. Report on grant writer study. Town Manager Helms reported that he received information from Blacksburg, Rocky Mount, and Galax, about how they handle grant writing needs, and found that Blacksburg's department directors take responsibility for grant writing, Rocky Mount hired an outsourced person, and Galax hired a grant writer/administrator in January 2012, with successful results. He added that the NRV Regional Commission has purchased a one-year subscription to Grant Finder, a searchable database for grants, and would be able to assist the Town with searching for appropriate grants. The NRVRC could also prepare grant applications for a nominal fee. Councilman Showalter commented that if the Town chooses the assistance of the NRV Regional Commission, it must be prepared to handle the daily management and reporting of the grants in-house, which is the most involved part of the grant process. Currently, the finance department handles all grant management and reporting, unless the grant is department related, and Finance Director Val Tweedie explained what is involved in bringing a grant to fruition. The Town currently manages approximately fifteen grants. After further consideration, and with Town Manager Helms' recommendation that the Town not hire a grant writer at this time, Council agreed to work with the NRV Regional Commission in searching and applying for grants, and to reconsider in the future if the Town's needs change.
2. Discussion regarding electronic tablets for Council's use. Town Manager Helms reported that there were funds in the annual budget for electronic tablets for Council use, and he asked that Council members discuss how they would like to use electronic tablets to determine what type of tablet setup would meet their needs. Assistant to the Town Manager Adam Carpenetti discussed with Council the various options and capabilities available, and Council asked that he put together a menu list of options, along with the average costs for devices and annual operation, for Council to consider and discuss at a future meeting.

VIII. COUNCIL REPORTS

- a. Councilman Showalter reported on the recent Central Business Advisory Committee meeting, noting that the committee had been invited to the Planning Commission meeting on November 16, 2015. He then reported that the Central Business Advisory Committee was scheduled to meet on November 17, and he would talk to committee members about the type of grant writing services the commission could provide the Town. Noting the concern presented by Coach Porter, Councilman Showalter recommended the town utilize its resources to educate school students on safety awareness and personal protection.
- b. Councilman Huppert announced that a reception will be held at the aquatic center on December 22, 2015 at 5:00 P.M. in honor of Councilman Vanhoozier's service on Town Council.
- c. Councilman Vanhoozier reported on the recent Stormwater Stakeholder meeting, noting that the group plans to present Council with a recommendation within the next few weeks.
- d. Councilman Hall reminded Council of the work session to discuss development of the Truman Wilson property. Regarding the concern presented by Coach Porter, Councilman Hall reported that as soon as the police department became aware of the situation, it stepped in and provided extra patrol through the area to keep those using the trail, and those around the mall, safe.
- e. Mayor Barber reported that he is unable to attend a ribbon cutting scheduled for November 19, and Councilman Vanhoozier offered to attend on behalf of the town. He then reported that the town, along with Montgomery County, would dedicate the Courthouse Square as Veteran's Monument Park during the Veteran's Day parade on November 11, 2015, and he reported on several community activities honoring veterans scheduled for November 11.

IX. TOWN MANAGER'S REPORTS:

WHEREAS, the Town of Christiansburg desires to submit an application for an allocation of funds of up to \$1,910,388 from the Virginia Department of Transportation Fiscal Year 2016-2017 Revenue Sharing Program; and,

WHEREAS, the Town plans to match this with up to \$1,910,388 to fund the projects described below; and,

Project Priority 1, Construction Project

Title: Park Street Sidewalk and Drainage Improvements

Total Estimated Project Cost: \$696,886

Requested State Matching Funds for Construction: \$348,443

Project Description: Installation of storm drainage piping and inlets in conjunction with curb, gutter and sidewalk improvements on Park Street from Depot Street to East Street. Project addresses street flooding and improves pedestrian access.

Project Priority 2, Maintenance Project

Title: Pavement Maintenance (Overlay)

Total Estimated Project Cost: \$1,000,000

Requested State Matching Funds for Construction: \$500,000

Project Description: Pavement overlay of Town streets meeting the criteria for funding coverage under the Revenue Sharing Program (Town-wide).

Project Priority 3, Construction Project

Title: Quin W. Stuart Traffic Signal

Total Estimated Project Cost: \$811,000

Requested State Matching Funds for Construction: \$405,500

Project Description: Installation of traffic signal at the intersection of Quin W. Stuart Boulevard and Peppers Ferry Road. Project addresses safety.

Project Priority 4, Construction Project

Title: North Franklin Street Storm Drainage Improvements

Total Estimated Project Cost: \$621,000

Requested State Matching Funds for Construction: \$310,500

Project Description: Installation of storm drainage piping and structure improvements in advance of future North Franklin Street improvements. Project addresses flooding and property damage.

Project Priority 5, Maintenance Project

Project Description: Repair/replace deteriorating culverts serving Town streets meeting the criteria for funding coverage under the Revenue Sharing Program (Town-wide).

Title: Guardrail Replacement

Requested State Matching Funds for Construction: \$6,000

Project Description: Replacement of guardrail at various locations serving Town streets meeting the criteria for funding coverage under the Revenue Sharing Program (Town-wide).

Project Priority 7, Construction Project

Title: Sidewalk Replacement

Total Estimated Project Cost: \$20,000

Requested State Matching Funds for Construction: \$10,000

Project Description: Replacement of sidewalks at various locations serving Town streets meeting the criteria for funding coverage under the Revenue Sharing Program (Town-wide).

Project Priority 8, Construction Project

Title: Arbor Drive Sidewalk Construction

Total Estimated Project Cost: \$255,300

Requested State Matching Funds for Construction: \$127,650

Project Description: Construction of sidewalks at various locations serving the businesses adjacent to Arbor Drive. Project addresses safety and pedestrian access to businesses in the immediate area.

Project Priority 9, Construction Project

Title: Roanoke Street Sidewalk Construction

Total Estimated Project Cost: \$374,590

Requested State Matching Funds for Construction: \$187,295

Project Description: Construction of sidewalks along the south side of Roanoke Street from Robert Street to Reading Road. Project addresses safety and pedestrian access to businesses in the immediate area, the Montgomery County Government Center and the bus transit stop.
