September 6, 2017

The meeting was called to order by Steve Simmons.

Shirley motioned to accept the minutes from last meeting with Amelia seconding.

1. Terry's Report
 - a. Revenue Report
 - i. FY 16-17 compared to FY 15-16
 - b. Special Olympics
 - i. In the past, Special Olympics has been held on Wednesday evenings which are busy with CAC programming. The staff of the CAC will offer availability in hopes to accommodate all services.
 - c. Request for disabled rate
 - i. The board has asked Terry to get more information from the individual requesting a special rate to see what can be worked out.
 - ii. Scholarship- the board has discussed this in the past without success due lack of funding options.
 - d. Active Net
 - i. A yearly membership- more than 365 days due to maintenance and swim meet closures during the year. The board agreed to leave the memberships the way they are now at just 365 days and when people inquire, add days.
 - e. Banner Sales
 - i. Very successful- running out of space to hang banners.
 - ii. Karen suggested charging for advertisement space on the big screen on the competition pool side.
 - f. Road-side banners
 - i. The board has agreed not to participate in road-side banners for outside organizations.
 - g. Age of senior citizen
 - i. A non-resident inquired at the parks and recreation about the senior age difference between facilities. Discussion was that the senior age should be determined by town officials with an evaluation of revenue lost due to the decrease.
 - h. Meeting time change
 - i. The board voted to move the meeting time to 4:30 p.m.

 - i. The board will meet when more direction is provided after a new town manager is hired.

 - ii. Training will include police, rescue and fire departments

 - i. We are hosting an internship with Christiansburg High School. Currently a student from the senior class works on specific projects and joins supervisors to gain knowledge about local government, aquatic programming and budgets, customer service and supervision.
