**DESCRIPTION:**

The Applicant requests a Conditional Use Permit (CUP) to establish a Comprehensive Sign Plan at 2400 North Franklin Street to permit additional wall signage on the front building wall (facing North Franklin Street) within the B-3, General Business District. The property is designated as Business/Commercial on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan.

Planning Commission held its public hearing on December 4, 2017 and during the same meeting recommended approval by a vote of 6 to 0 with two conditions:

1. The comprehensive sign plan shall only modify the allowable permanent wall signage. Temporary signage shall comply with Article XXIV – Signs of Chapter 42 “Zoning” of the *Christiansburg Town Code*.
2. The permanent wall signage shall be in general conformance with the proposed sign schedule, as shown on Sheet A2 – *Exterior Elevations* and Sheet A2.1 – *Exterior Signage and Details*, dated October 26, 2017.

A JOINT WORK SESSION OF THE CHRISTIANSBURG TOWN COUNCIL, MONTGOMERY COUNTY, CHRISTIANSBURG, VA. AND THE PARKS AND RECREATION ADVISORY COMMISSION WAS HELD AT CHRISTIANSBURG TOWN HALL, 100 EAST MAIN STREET, CHRISTIANSBURG, VIRGINIA, ON DECEMBER 12, 2017 AT 5:00 P.M.

**WORK SESSION**

- I. Call to Order by Mayor Barber
- II. Discussions by Mayor, Council Members, and Members of the Parks and Recreation Advisory Commission
  - A. North Christiansburg Regional Park.

Mr. John Neel, Gay and Neel, Inc., presented Council with two conceptual phasing options for development of the North Christiansburg Regional Park, which he explained were drafted based on Council discussions during prior work session discussions regarding the park property. Mr. Neel provided the project budget estimate summary for both options, and noted that the main difference between the two options related to the development of the future access/connector road. Council talked about developing the property in phases as a way to expedite public use of the park, specifically beginning with Phases 1, 2, and 3, as presented by Mr. Neel, which included creating site access, mass grading, stormwater management, utilities, soccer fields, parking lot, dog park, meadows, trails, and pavilions. Mr. Neel and Council discussed the option to mass grade the site as a way to cut overall construction costs, and they reviewed the alternative summaries “A” “B” and “C”, provided by Gay and Neel, Inc., that offered timelines and breakdowns of cost for initial phasing options with mass grading. Using the concept plans provided, Council and Mr. Neel discussed various ideas for maximizing outparcel potential and rearranging different aspects

of the park for optimal land use. Council expressed interest in Gay and Neel providing information on the cost impact of removing the dog park and baseball fields from the concept plans. It was noted that Montgomery County planned to construct a softball field on the high school property that could be utilized by the Town. Council discussed with Finance Director/Treasurer Val Tweedie the financial aspects of developing the park, including debt service and bond opportunities, along with probable costs of construction and projected operating costs, and cost offset from the future sale of outparcels. Council talked about the debt that would be incurred with development of the park, and Ms. Tweedie confirmed that construction could not be funded out of current revenue streams, and that there was no revenue to offset the costs at this time. Construction of the park was estimated to be approximately \$20M to \$25M, with possible annual operating costs of \$1M. Ms. Tweedie noted that there were several capital improvement projects in the future, including major reconstruction at the Wastewater Treatment Plant, and that she was uncomfortable funding the entire park construction at one time. Council discussed various ways to generate funds to meet construction costs, including grants, sponsorship programs and possible future tax increase.

Council discussed the importance of providing open greenspace at the park, and speculated on the types of businesses that may be developed on the outparcels and the possible impact of those on the park. Mr. Neel noted that a grading difference would provide a significant buffer between the park property and commercial development.

Members of the Recreation Advisory Commission said that many of the parents involved in youth sports at the recreation center were excited about the proposed development of softball fields, and would be disappointed if the fields were removed from the concept plans. The group encouraged Council to move forward with developing the park as proposed to the public in May 2015, or at least to develop multipurpose rectangular fields that could be used for softball. Members also stressed that the public frequently asked about the construction timeline and were excited about the prospect of a Town park.

Council expressed support for the Conceptual Phasing Plan – Option 1 presented by Mr. Neel, but expressed concern with the proposed construction costs of approximately \$15M, due to mass site grading. Council requested Ms. Tweedie prepare a financial plan for Phasing Plan – Option 1, Phases 1 – 4, to include grant funding, bond amounts with probable, variable interest rates, and a list of possible options for generating revenue. Council also requested that Mr. Neel provide a scaled down map of the exact details of the initial construction phase that would include Phases 1 – 4 of Option 1 of the phasing plan, without the dog park and softball field, and with the third outparcel, as discussed.

## VII. INTRODUCTIONS AND PRESENTATIONS

- A. Town Council & Christiansburg High School Partnership.  
Students from the high school were unable to attend due to exams.
- B. Presentation by Christy Straight, Regional Planner II, New River Valley Regional Commission on the New River Valley Hazard Mitigation Plan, 2017 update.

Christy Straight thanked Council for the opportunity to present an overview of the New River Valley Hazard Mitigation Plan for 2017, and explained the focus of the plan on avoiding or minimizing the impacts of future hazardous events. The regional mitigation plan must be approved by all localities within the New River Valley before receiving approval from FEMA. Ms. Straight shared the details of the plan and noted that Town staff from the Planning, Engineering, and Fire departments were involved in providing information and data used to develop a plan that would address and mitigate potential hazards specific to the region. More

information about the plan can found at NRVRC.org. Council was provided a resolution in support of the New River Valley Hazard Mitigation Plan, which was acted on later in the meeting. Council expressed appreciation for Ms. Straight's efforts in developing the plan and bringing it before Council for consideration.

- C. Wayne Nelson, Engineering Director, to present the Cambria Street Intersection and North Franklin Street Corridor Improvement project design, which incorporates Design Public Hearing comments relevant to the major design features of the project.

Mr. Nelson introduced Rick Delong, Director of Transportation Engineering with McCormick Taylor, Inc., project design consultants, and directed Council attention to the resolution of support required for moving the project forward to the right-of-way acquisition and final design phase. Mr. Nelson talked about the features of the project design, connections, and reconfigurations using an aerial map, and explained the traffic analysis and discussions with VDOT that were used in advancing the design being presented, with access management and safety a priority for the design along North Franklin Street from Cambria Street to Independence Boulevard. Mr. Nelson noted that Council was provided a map of the proposed corridor improvements, along with a transcript of the design public hearing in the agenda packet for review. Mr. Nelson also reviewed with Council the proposed future reconfiguration of the North Franklin/Cambria intersection that would allow for a more efficient traffic flow, and stated he hoped funds would allow for an upgrade to the signal at that intersection. Council discussed with Mr. Nelson the project timeline, and the probability of a future reduction in the speed limit along North Franklin Street with the construction of sidewalks. Council expressed appreciation for Mr. Nelson and Mr. Delong's efforts on the project.

*Mayor Barber acknowledged and welcomed to the meeting Joseph Young, manager of New River Valley Golf since 2016. He also welcomed his wife, Erlene, and granddaughter, Maggie, who were present to support him as he took the Oath of Office.*

- D. Presentation by Mayor Barber. Mayor Barber announced that Councilman Cord Hall would be retiring from Town Council after serving two terms, and presented him with the gift of a clock from Council. Mayor Barber read the inscription on the clock honoring his service to the Town, and commented that he would be missed. Councilman Hall thanked Council for the gift and said he would miss being a part of Town Council and the Recreation Advisory Commission. Mr. Hall thanked the citizens for their trust in electing him twice to Council. He stated he would cherish the relationships he had formed during his time on Council and was proud of the Town's accomplishments over the past eight years.

Steve Simmons' term on the Aquatic Advisory Board expires on December 31, and he has agreed to serve another four-year term. Councilman Huppert talked about the efforts of the Aquatic Advisory Board and Aquatic Director Terry Caldwell to encourage community participation at the aquatic center, and reported on the recent swim meet that hosted thirteen hundred swimmers. Ms. Caldwell reported on the success of the Black Friday Sale held in November that netted \$53,000 in memberships, a significant increase over last year's Black Friday Sale that doubled town resident memberships, and she reported on upcoming aquatic events. Council commended the efforts of the aquatics staff, and asked Ms. Caldwell to pass along their comments to her staff.

2. Rezoning Request by John Neel, Gay and Neel, Inc., agent for Sarah Crawford, for a portion of Tax Map No. 530-(2)- 87A 1 [Parcel ID 01937] located on the corner of Glade Drive SE and Curtis Drive SE from A, Agricultural to R-3, Multi-Family Residential. The property is designated as Residential on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan. The Public Hearing was held November 28, 2017.

Councilman Stipes made a motion to approve the rezoning as recommended by the Planning Commission, seconded by Councilman Showalter. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Hall – Aye; Huppert – Aye; Showalter – Aye; Stipes – Aye.

3. Christiansburg Fire Department and Rescue Squad volunteers have historically been covered by the Workers' Compensation Act, but it was recently brought to the Town's attention that there is no resolution on file with the Virginia Workers' Compensation Commission, as required by Code of Virginia § 65.2-101 to provide the coverage. This resolution is necessary to continue providing the coverage.
