 - A. Lisa Bleakley, Director of the Montgomery Tourism Development Council, provided an update on tourism activities.

Lisa Bleakley introduced Irene Kilmer, Visitor Relations Manager, then presented Council with a detailed overview of the Montgomery County VA Regional Tourism Program that works in partnership with the communities of Christiansburg, Blacksburg, and Montgomery County to stimulate economic opportunity, promote Montgomery County as a tourism destination, and celebrate and promote the area's culture and heritage. Ms. Bleakley explained program funding, and reviewed information on travel economic impacts, hotel occupancy, and local tax receipts, which were provided by the Research Department of the U.S. Travel Association and Smith Travel Research, respectively. Ms. Bleakley noted that funding from the Town was used to support travel media promoting Montgomery County, which had caught the attention of PBS and would be featured during a television series, Erik the Travel Guy, in April 2018. Ms. Bleakley and Council discussed the 2018 goals of the TDC that included a focus on group and business travel, a focus on soft periods, marketing products, advertising revenue, and partnerships. A copy of Ms. Bleakley's presentation is attached herewith for reference.

III. PUBLIC HEARINGS

- A. Rezoning request by John Elmore, agent for Donald and Rachel Wood, for an approximately 1.15-acre portion of tax map no. 435- A 20 located at 840 Peppers Ferry Road, N.W. from A Agricultural to B-3 General Business. The property is designated as Residential on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan.

John Elmore, agent for Donald and Rachel Wood, thanked Council for the opportunity to speak and explained that he and his wife, Juanita, who was present, agreed to purchase the 1.15-acre portion at 840 Peppers Ferry Road, if the rezoning was approved. Mr. Elmore said that the sale would be mutually beneficial as he and his wife wanted to use the property to expand their existing storage facility, and the Woods wanted to sell to use the proceeds for needed home repairs. He noted that the only access to the 1.15-acre portion was through either his or the Woods property and is not being farmed at this time. He further noted that the storage facility expansion would not be visible from Peppers Ferry Road. The Planning Commission voted unanimously to recommend approval of the request.

- B. Ordinance amendment to Chapter 42 "Zoning" of the Christiansburg Town Code to allow for research, experimental, or testing laboratories including animals in the I-2, General Industrial District, with a Conditional Use Permit.

Interim Town Manager Randy Wingfield explained that currently Town Code prohibits testing on animals, and he believed the original intent was to prohibit testing for cosmetics and perfumes. The Town has learned that an animal testing facility has expressed interest in property located in the Falling Branch Industrial Park that uses animals for medical research. Mr. Wingfield noted that the code amendment would be for all I-2 General Industrial zonings, further noted that Montgomery County wanted the amendment for future prospects. The ordinance amendment received unanimous support of the Planning Commission.

Chris Waltz, 1370 Rigby Street, said he spoke with the director of Montgomery County Economic Development who commented he was acting as agent for the animal testing company, and that the company was more than just a prospect. Mr. Waltz said the director refused to reveal the name of the company and he was concerned that may involve the DOD, which is involved in

vaccine development research. Mr. Wingfield commented that the Town was not aware of the name of the corporation.

Brian Hamilton, secretary/treasurer of Montgomery County Economic Development Authority, stated it was fairly standard practice in Virginia to allow animal testing facilities in industrial parks, and that there were two animal testing facilities currently in operation in Montgomery County. Mr. Hamilton said that amending the ordinance would alleviate hindering future development.

- C. Contingent on the above ordinance amendment, Conditional Use Permit request by the Economic Development Authority of Montgomery County for tax map parcel 599-1 7 (3.691 acres) to allow for research, experimental, or testing laboratories including animals in the I-2, General Industrial District, with a Conditional Use Permit. The property is designated as Industrial on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan. See comments above.

VI. INTRODUCTIONS AND PRESENTATIONS

- A. Town Council and Christiansburg High School Partnership.

Students, Nicole Diloia, president of the Student Government Association (SGA), Brook Simpson, secretary of the SGA, and Jasmine, reporter for the SGA, reported that the high school wrestling team was participating in the state championship competition in Portsmouth this weekend, and the girls and boys track teams won region for indoor track, with the state championship competition later this month. Ms. Diloia told Councilman Collins she would get him information on the wrestling team booster club, and all three students agreed with the idea of the high school SGA participating in a “local government day” at Town Hall. Mayor Barber asked Councilman Collins and Mr. Wingfield to organize the event with the school. Councilman Collins and Councilman Showalter offered to work with school staff to organize a celebration of the wrestling team. Council thanked the students for the update.

B. Terry Smusz, CEO, and John McEnhill, Board of Directors Chair, to present New River Community Action's Annual Report.

Tonia Winn, Christiansburg representative on the New River Community Action (NRCA) Board, addressed Council in place of Mr. John McEnhill on the 2016-2017 operations of NRCA. Ms. Winn began her report by thanking Christiansburg for its support of the non-profit organization and noted that in 2016-2017, it had served 3,736 clients in Montgomery County through emergency assistance programs, Virginia Cares program that assists with transition from jail to public, To Our House which assists homeless men in partnership with local churches, Head Start, which served 57 children, and the Swift Start program that offered career mentoring to 47 participants. Ms. Winn talked about the importance of the emergency assistance programs that, in partnership with local communities, offered financial assistance and provided food through food pantries and backpack programs, and served 8,205 individuals and 3,531 families in 2016-2017.

Terry Smusz described to Council the homeless and housing programs offered at NRCA designed to assist with housing needs and educated individuals on the aspects of renting. Ms. Smusz noted that the contributions from Christiansburg directly supported the housing programs. NRCA also supports the Women's Resource Center in Radford, which provides emergency housing for women and children.

Mayor Barber noted that NRCA has been serving the Christiansburg community for many years and he appreciates all they do, and Council commended the efforts of NRCA to responsibly serve Montgomery County.

C. Ben Robson to report on The Big Event 2018.

Ben Robson, Virginia Tech student, reported on The Big Event 2018 scheduled for April 7. The student-run community service event is the second largest of its kind in the nation, with 8,223 volunteers for 1,174 projects in 2017. The goal for 2018 is 10,000 volunteers for 1,300 projects and is being organized by a team of 140 staff members and directors. Mr. Robson shared with Council a positive comment from a homeowner served during The Big Event, and he explained how the Town of Christiansburg can get involved through volunteering and encouraging residents to sign up with projects. Councilman Showalter noted that Christiansburg participates in the Achieving College & Career Education (ACCE), which requires community service hours and The Big Event could be a good volunteer opportunity for participants. Mayor Barber noted that he, Melissa Demmitt, and Anaika Miller would be meeting with one of the directors of The Big Event 2018 on Friday to discuss ways Christiansburg can get involved.

D. Terry Caldwell, Director of Aquatics, to present Christiansburg Aquatic Center "2017 in Review".

Terry Caldwell began her report by welcoming Amelia Tuckwiller, member of the Aquatic Advisory Board who was present in support of the aquatic center, and by thanking Council for its continued support of the aquatic center. Using PowerPoint, Ms. Caldwell shared photos of citizens using the facility and talked about community commitments and involvements that included Christiansburg High School based instruction, interns through the high school and Radford University, partnership with Montgomery County for the SOUPer Splash event and coat drives, PTA events, donations of memberships/passes in the community, toy drives at Christmas, and hosting the Special Olympics last fall that had 67 athletes. Ms. Caldwell called attention to the various efforts to increase participation and membership through community involvements, family events, special offers, and fundraisers, and highlighted special programs such as the adult learn to swim, and the Montgomery County Public School second grade swim lesson program

offered in partnership with the Blacksburg Lions Club and the New River Health Foundation. The second grade swim lesson program served over 700 children in 2017, including 100 children from McHarg Elementary in Radford. In addition, Ms. Caldwell shared information on the success of the summer camp and after-school Club CAC programs, and room rentals for parties. Ms. Caldwell was pleased to announce that through the diligent efforts of Olivia Heller, Program Coordinator, Feeding America just gave a verbal commitment to provide meals for the summer camp program, which would allow the aquatic center to apply for a grant from the National Parks and Recreation Association that would provide \$25,000 for food.

In 2017, the CAC hosted thirty-seven swim/dive meets that included high school, regional, and college teams, and one water polo tournament. The CAC summer swim team, Blue Fins, had sixty participants and placed 4th in the SVSL. Ms. Caldwell talked about the demand for swim meets to be scheduled early in the year, and she commended Ian Dye, Aquatic Tournaments Coordinator, for successfully coordinating the meets hosted at the aquatic center.

The CAC partners with the Tourism Development Council to place maps and information for visitors in the lobby of the aquatic center. Ms. Caldwell said she attends tourism meetings and appreciates the collaboration that makes swim meets successful and brings in visitors. Ms. Caldwell provided a brief overview of the swim/dive meets scheduled for 2018 that included high school and college teams, and she talked about the future of swim within the swim team culture and how that could impact the aquatic center.

In closing, Ms. Caldwell talked about the challenges faced by the facility specifically in obtaining and retaining lifeguards, and in aging/dated equipment. Lifeguard pay is currently \$8.25/hour and hours are limited to less than 25 hours/week. Currently, a lifeguard must work for three years before being eligible for a \$0.25 raise. Ms. Caldwell pointed out that lifeguards are first responders and have a tremendous amount of responsibility protecting the lives of swimmers. Lifeguard training is offered for free, and although aquatics staff works within the community to recruit individuals, there is often a shortage that is compensated for by full-time staff. Councilman Stipes asked if the pay for lifeguards needed to be adjusted. Ms. Caldwell noted that a request had been made during budget planning last year, but was eliminated during the budget process. Councilman Showalter recommended Ms. Caldwell present a lifeguard pay plan proposal for consideration during the 2018 budget process, and encouraged her to keep Council updated on the equipment needs at the facility and to involve the advisory board in pinpointing specific needs that will keep the facility up-to-date and competitive. Councilman Collins expressed support for the second grader swim lesson program, and asked Ms. Caldwell to look into how much it would cost to add additional grades to the program. Council expressed appreciation for the update.

VIII. DISCUSSION BY MAYOR AND COUNCIL

- A. Rezoning request by John Elmore, agent for Donald and Rachel Wood, for an approximately 1.15-acre portion of tax map no. 435- A 20 located at 840 Peppers Ferry Road, N.W. from A Agricultural to B-3 General Business. The Planning Commission voted unanimously to recommend approval. Councilman Stipes made a motion to approve the rezoning as recommended by the Planning Commission, seconded by Councilman Collins. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Absent; Showalter – Aye; Stipes – Aye.

X. STAFF REPORTS

A. Town Manager Wingfield:

- Councilman Bishop currently serves on the Montgomery Tourism Development Council and is up for reappointment. Mr. Wingfield, as a voting member of the Tourism Development Council Board, intends to nominate him for reappointment. An alternate member is needed and Council agreed to nominate Steve Huppert to serve as alternate.
- Mr. Wingfield has been asked to sign letters of commitment for the 2018 fiscal year for \$4,000 for a New River Valley Housing Study by the NRV Regional Commission with the Virginia Center for Housing Research; and \$7,000 to fund a Small Business Development Center employee position to serve the New River Valley out of the Roanoke office. Council authorized Mr. Wingfield to sign both commitment letters.
- The court case for the ongoing noise ordinance violation on Dow Street has been continued for ninety days pending a review of the Town's noise ordinance. During the hearing, Town Attorney Fontana informed the judge that the Town was considering an amendment to the ordinance that would move it to the zoning ordinance and would require a Conditional Use Permit. Violations would be a civic matter with fines. Attorney Fontana said the goal in amending the ordinance was to provide a simpler, easier to understand and enforce ordinance. A public input meeting for the amendment has been scheduled and the matter will go before the Planning Commission for review and recommendation. Town Attorney Fontana, Planning Director Andrew Warren, and Police Chief Sisson worked together to develop the working draft ordinance amendment.

- A. Councilman Huppert thanked Terry Caldwell for the report on the aquatic center, and for promoting Relay for Life. He then encouraged Council to attend the H'arts on Main event this weekend.
- B. Councilman Stipes recognized the efforts of VDOT resident engineer, David Clarke, for improving the timing of the stoplights at the intersection of North Franklin Street and Peppers Ferry Road, at his request a week ago, and he thanked him for his responsiveness.
- C. Councilman Showalter reported on the recent NRV Regional Commission meeting where new members were introduced. Mr. Showalter said he was pleased to have so many neighbors working towards one goal. He then informed that Radford may lead as the entitlement community with CDBG funds. He then spoke about the economic envisioning discussed at the meeting and thought it would be beneficial to have an economic envisioning workshop with the Town's stakeholders and the NRV Regional Commission to discover the economic priorities of the Town. Mr. Showalter asked Mr. Wingfield to include this matter as a goal for 2018.
- D. Councilman Bishop – No report.
- E. Councilman Collins added to Councilman Showalter's comments noting that the NRV Regional Commission has agreed to assist the Town in a transportation study once the railway comes to Christiansburg. He then reported that Planning Commission application period has closed, with three applications received. Interviews will be held February 20, 2018 at 5:30 P.M.

F. Mayor Barber expressed his condolences at the passing of Meghan Dorsett. Meghan served on the Town's Planning Commission and was heavily involved in the Town. Meghan will be missed by many. He then reported on the H'arts on Main event scheduled for February 16 & 17 and encouraged all to attend.
