A REGULAR MEETING OF THE CHRISTIANSBURG TOWN COUNCIL, MONTGOMERY COUNTY, CHRISTIANSBURG, VA. WAS HELD AT CHRISTIANSBURG TOWN HALL, 100 EAST MAIN STREET, CHRISTIANSBURG, VIRGINIA, ON MARCH 26, 2019 AT 7:00 P.M.

III. PUBLIC HEARING

- A. Street vacation request by Hash Investments LLC for an ordinance vacating the entirety of Bristol Drive, S.E. (approximately 22,000 sq. ft.) located between 2395 Roanoke Street (tax map no. 500-3-B2), 2435 Roanoke Street (tax map no. 500-A-10) and 100 Bristol Drive, S.E. (tax map no. 500-3-C).

Thom Rutledge, Project Manager for Hash Investments, LLC, offered to answer questions of Council regarding the street vacation request. Mr. Rutledge explained that Hash Investments had purchased the last parcel at the end of Bristol Drive and now owned all the property along Bristol Drive. The Planning Commission reviewed the request and has recommended approval. Councilman Collins announced he would abstain from all voting on this matter to avoid any perceptions of a conflict of interest. Councilman Stipes noted that there was no spoken opposition to the street vacation request, and he made a motion to add the request to tonight's agenda for discussion and action. Councilman Huppert seconded the motion and Council voted as follows: Bishop – Nay; Collins – Abstain; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

Councilman Stipes made a motion to approve the consent agenda, seconded by Councilman Showalter. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes - Aye.

V. INTRODUCTIONS AND PRESENTATIONS

- A. Introduction of New Employees

- B. Montgomery County Board of Supervisor Representative Chris Tuck to provide an update on Montgomery County.

Montgomery County Board of Supervisor Chris Tuck provided Council with a printout of his PowerPoint presentation and thanked them for the opportunity to speak. Mr. Tuck has served on the Montgomery County Board of Supervisors for eight years and has served as both chair and vice-chair, but noted that tonight he would be speaking on behalf of himself, not the county. Mr. Tuck provided an overview of the county's proposed budget for FY 2020, that included a breakdown of revenue and expenses, and called attention to the proposed school budget that projected an increase in school operations. Mr. Tuck talked about the challenges in addressing overcrowding and aging facilities in the Christiansburg strand, and reported that discussions regarding those concerns have focused on a choice between renovating Belview

Elementary, Christiansburg Elementary, and Christiansburg Primary, or renovating Christiansburg High. Mr. Tuck stressed funds were not available to renovate all four at the present, and that county discussions did not necessarily include any new construction in Christiansburg. Mr. Tuck asked Council for guidance in determining which avenue to pursue in addressing the school building needs in Christiansburg. In closing, Mr. Tuck presented the county's short-term and future capital projects, which included proposed expansion of broadband service, and offered to answer questions of council. Council discussed overcrowding and potential redistricting in Montgomery County, and expressed appreciation for Mr. Tuck's service and advocacy of Christiansburg. Council also acknowledged and welcomed board of supervisor representatives April Demotts and Chair Todd King.

- C. Resolution recognizing Chris Tuck for his service as chair of the Montgomery County Board of Supervisors. The resolution was adopted by Council January 8, 2019.

Mayor Barber presented Chris Tuck with a resolution recognizing his service on the Montgomery County Board of Supervisors, and thanked him for his advocacy of Christiansburg during his years of service on the board. Mr. Tuck said it was a great honor to receive the resolution and thanked Mayor Barber and members of Council for the recognition.

- D. Justin Sanders, President, Downtown Christiansburg Inc. (DCI) to provide an organizational update and to request street closures for the Wine and Artisans Event on Saturday, May 4, 2019.

Justin Sanders introduced himself and the DCI leadership team to Council and presented the vision and mission statement of DCI. Mr. Sanders talked about the goals of the volunteer-based organization, and the importance of its community partnerships and collaboration with the Town to the success of its programs and events. The organization recently secured 501(c)(3) status and is recognized as a commercial district affiliate with the Virginia Main Street Program, which will open the Town up to numerous grant programs. Mr. Sanders talked about the organization's involvements and initiatives in promoting downtown businesses, and efforts to grow its membership program through strategic planning based on recommendations from the Virginia Tech Office of Economic Development. Mr. Sanders talked about the success of the DCI hosted events in 2018 and presented the 2019 Events Calendar, along with a request for street closures for the Wine and Artisans events on May 4. Council thanked Mr. Sanders for the update and for the organization's efforts to bring vibrancy to the downtown area. Councilman Showalter commented he hears many positive comments from the community on the downtown events.

- E. Christiansburg Institute Executive Director Chris Sanchez to present regarding Christiansburg Institute, Inc.

Marcy Schnitzer, Vice-Chair of the Christiansburg Institute (CI) Board, and Debbie Sherman-Lee, Treasurer, presented Council with an update on CI and progress on efforts to address roof reconstruction on the Edgar A. Long building. Ms. Schnitzer reported that CI received \$300,000 in the fall of 2000 from the state that was administered through HUD as a special projects grant, and funded the planning stage of the roof renovation project, which is now construction-ready. Photos were shown of the existing building and roof disrepair. Ms. Sherman-Lee provided an overview of the funds raised in 2018-2019 that totaled \$27,500, and reported on outstanding grant applications, efforts to expand community partnerships and involvements, and the current action plan in moving forward with the roof reconstruction. Ms. Sherman-Lee

thanked the Town for its continued support of the efforts to preserve CI has a historic site, and presented CI's budget request of \$75,000 to support the roof renovation project.

VI. CITIZEN COMMENTS

- A. Chris Waltz, 1470 Rigby Street, questioned why the Conditional Use Permit request by Cole Shows Amusement Co., Inc. (March 13, 2019), was approved by Council with restrictions not applied to events held by Downtown Christiansburg, Inc., until this year, claiming that the Special Events Ordinance was not content neutral or fairly applied.
- B. Karen Jones, 9 Depot Street, N.E., supported the plan proposed by Chris Tuck for renovation of several Christiansburg strand schools, and commended Downtown Christiansburg Inc., for bringing vibrancy to Christiansburg. In addition, Ms. Jones, a board member of the Christiansburg Community Center, said she was present in support of Christiansburg Institute and shared that several of her family members had attended or graduated from CI. Ms. Jones talked about the importance of educating the community on African American history and she expressed support for the proposed renovation of the Edgar A. Long building.

VIII. DISCUSSION BY MAYOR AND COUNCIL

- A. Council action on:
 1. Rezoning request by F&B LAND, LP for an amendment to proffers on an approximately 38-acre portion of tax map no. 525-A-4, located north of Diana Dr. N.W., east of Aldwych Ave. N.W., and south of Kensington Way, N.W. in the Kensington Subdivision. The property is zoned MU-1 with proffers and the request is to amend the proffers accepted with the 2006 rezoning action. The property is designated as Residential on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan. The Public Hearing was held March 12, 2019. **The applicant has requested Town Council postpone action on this item until the May 28, 2019 meeting.** Councilman Showalter made a motion to table the request, seconded by Councilman Collins. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Collins – Aye.
 2. Rezoning request by Cambria Storage Partners, LLC, agent for Kenson, Inc for an approximately 4-acre property located at 300 and 390 Cambria Street, N.W. (tax map no. 466-27-A) from the B-1, Limited Business District to the MU-1, Mixed Use: Residential-Limited Business District. The property is designated as Residential on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan. The Public Hearing was held March 12, 2019.

Councilman Stipes made a motion to approve the rezoning as recommended by the Planning Commission, seconded by Councilman Showalter. Council voted on the motion as

follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

3. Conditional Use Permit request, contingent on the preceding item, by Cambria Storage Partners, LLC, agent for Kenson, Inc for mini-warehouses and related retail at 300 and 390 Cambria Street, N.W. (tax map no. 466-27-A) in the MU-1, Mixed Use: Residential-Limited Business District. The Public Hearing was held March 12, 2019.

Councilman Showalter commented he was impressed by the professional community involvement session hosted by the applicant during the planning phase, and he made a motion to issue the CUP with one condition as recommended by the Planning Commission. Councilwoman Sachs seconded the motion and Council voted as follows: Bishop – Aye; Collins – Aye; Huppert – aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

4. Conditional Use Permit request by Cole Shows Amusement Co Inc, agent for NRV Mall Associates LLC for a carnival at 782 New River Road, N.W., (tax map no. 435-A-41) in the B-3, General Business District. The Public Hearing was held March 12, 2019.

Planning Director Will Drake reported that the Planning Commission recommended approval of the CUP with fourteen (14) proffers. Councilwoman Sachs made a motion to accept the Planning Commission recommendation to issue the CUP with fourteen conditions, seconded by Councilman Showalter. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye. Mayor Barber, in response to comments by Chris Waltz during the citizen comment period, noted that the CUP conditions for Cole Shows Amusement Co. Inc., were consistent with the conditions placed on clubs that have hosted carnivals in Christiansburg.

5. Street vacation request by Hash Investments LLC for an ordinance vacating the entirety of Bristol Drive, S.E. (approximately 22,000 sq. ft.) located between 2395 Roanoke Street (tax map no. 500-3-B2), 2435 Roanoke Street (tax map no. 500-A-10) and 100 Bristol Drive, S.E. (tax map no. 500-3-C). The Public Hearing was held earlier in the meeting.

Councilman Showalter made a motion to approve the street vacation as requested, seconded by Councilwoman Sachs. Council voted on the motion as follows: Bishop – Aye; Collins – Abstain; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

- B. Reappointment of Barry Helms to the Montgomery Regional Solid Waste Authority Board to a four-year term from July 1, 2019 until June 30, 2023.

Councilman Showalter made a motion to reappoint Barry Helms to the Montgomery Regional Solid Waste Authority Board for a four-year term ending June 30, 2023. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye. Council thanked Mr. Helms for his service, and Mr. Helms thanked Council for the reappointment.

- C. Request by Downtown Christiansburg Inc. for street closures for the Wine and Artisans event on Saturday, May 4, 2019.

Councilman Showalter made a motion to approve the street closures as requested, seconded by Councilman Collins. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

D. Contract with Acorn Sign Graphics, Inc. in the amount of \$434,335.60 for wayfinding signs.

Public Relations Director Melissa Demmitt reported on the wayfinding sign program that received six RFP's for sign fabrication and installation. All six RFP's were overbudget and Town staff reduced the sign type list, then a revised price list was submitted by the bidders to compare like sign types. As a result, Acorn Sign Graphics, Inc. was the selected bid in the amount of \$434,335.60. The original budget for sign fabrication and installation was \$400,000, and additional funding of \$34,335.60 would need to be budgeted for the program in FY 2019-2020. Councilwoman Sachs noted that no local bids were received for this project. Sign landscaping would be done by the Public Works Department. Councilman Showalter made a motion to approve the contract with Acorn Sign Graphics, Inc. in the amount of \$434,335.60, seconded by Councilman Stipes. Council voted on the motion as follows: Bishop – Aye; Collins – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

DESCRIPTION:
The proposed amendment to the performance agreement would grant a nine month extension for the completion of work scheduled from June 30, 2019 to March 30, 2020. The developer has progressively worked through the design phase of the stormwater pond, other site infrastructure improvements, and the Arby's relocation with the Town and has also worked with VDOT on the signal design at Shoppers Way and North Franklin Street. Construction has commenced on the site and staff believes this extension will be adequate for the agreed upon improvements to take place. The Amendment also recognizes the ownership change that has taken place within the development organization and on the property since the original agreement was complete.
