Councilman Bishop made motion to approve the consent agenda, seconded by Councilwoman Sachs. Council voted on the motion as follows: Bishop – Aye; Hicks – Aye; Huppert – Aye; Sachs – Aye; Showalter – Aye; Stipes – Aye.

V. INTRODUCTIONS AND PRESENTATIONS

- A. Chris Sanchez, Debbie Sherman-Lee, and Marcy Schnitzer to present regarding Christiansburg Institute, Inc.'s amended community support request for Fiscal Year 2020-21 Budget.

Mr. Sanchez, Ms. Sherman-Lee, and Ms. Schnitzer thanked the Town for its support over the years, then collectively provided a detailed update on the progress of Phase 1 of the renovation of the Edgar A. Long building that included replacement of the roof and roof system, and photos of the project were included in the presentation. The group reported that the community support request of \$15,000 would support strategic planning for Phase 2, reworking the current window boarding and developing a plan for the restoration/repair of all 52 historic windows on the structure, and installing security cameras. Mr. Sanchez continued to provide a detailed overview of Phase 2, along with a breakdown of funding and expenses. The group discussed its vision for the historic property as a culturally rich asset, and invited Council to sign an online petition of support for the restoration of the Edgar A. Long Building. Councilwoman Hicks encouraged the group to apply for grants to expedite the renovation process.

VII. COMMITTEE REPORTS

VIII. DISCUSSION AND ACTION BY MAYOR AND COUNCIL

- A. Town homepage COVID 19 community support web banner (Showalter). Councilman Showalter proposed the Town add a COVID 19 community support banner on its website that would highlight donation opportunities to various organizations that rely on community support, and would include a link to each organization's webpage for direct donations. Council had briefly raised the idea of this matter during a recent work session, and Town Manager

Wingfield noted that a COVID 19 community support web banner that contained the details mentioned by Mr. Showalter had been activated on the Town's homepage this week.

B. Recognition of Christiansburg High School 2020 Graduating Class (Showalter)

Council discussed a variety of options for recognizing Christiansburg High School 2020 seniors, with Councilman Showalter proposing to add a banner to the Town's website homepage that would highlight the students, and would include a link to Christiansburg High School's Facebook page where a brief bio of each graduate could be read. In addition, Councilman Showalter recommended displaying the Christiansburg High School flag to alternate with the star-spangled flag along Main Street. Council supported Mr. Showalter's proposal for a web banner honoring Christiansburg's 2020 seniors, and his suggestion pertaining to the flags displayed along Main Street.

C. Community Tilling Program

Town Manager Wingfield presented a proposal for a Community Tilling Program designed to help facilitate community food production by tilling two Town-owned community use spaces for community gardens and the proposed emergency services property, and offering tilling services for property owned by Christiansburg non-profit organizations for community garden use. Parks and Recreation staff would oversee the tilling program, and maintenance of the community garden space would be the responsibility of the non-profit. The tilling program is an effort to address community needs resulting from the coronavirus outbreak, and the Town will consider opening the program to citizen-owned property at a later date. Council expressed support for the proposed program and gave consensus for Town Manager Wingfield to move forward with its implementation.

IX. STAFF REPORTS

A. Town Manager:

- Set public hearing for May 12, 2020 for a lease agreement for property at 415 Cambria Street, NW.
- Set public hearing for May 26, 2020 for the Annual Budget for FY 2020-2021.
- Blacksburg Transit received funding through the Cares Act that would support continued operation of the Town's commuter route to Blacksburg. Councilman Stipes commented that he had received an email from a citizen expressing the importance of the commuter route, and he voiced support for continuing the route if funded as noted. Council unanimously agreed to support continued operation of the commuter route funded by the Cares Act.

C. Other Staff:

- Fire Chief Billy Hanks, Police Chief Mark Sisson, and Rescue Chief Joe Coyle reported on ongoing activities and efforts of the NRV Public Health Task Force to address public health and safety during the coronavirus outbreak. Special thanks was given to Feeding America for its recent support of the community through food distribution at Christiansburg High School. The program is a tremendous community resource that has made a significant impact during this time of crisis. Mr. Hanks, Mr. Sisson, and Mr. Coyle thanked the public

for its efforts to comply with safety recommendations to help stop community spread of COVID 19.

X. COUNCIL REPORTS

- A. Councilman Huppert expressed appreciation for the opportunity to observe the COVID 19 testing site.
- B. Councilman Stipes expressed appreciation for the progress report by Christiansburg Institute, and noted his approval for continued financial support for the preservation of the property.
- C. Councilman Showalter, no report.
- D. Councilman Bishop expressed support for the continued financial support for the preservation of Christiansburg Institute.
- E. Councilwoman Sachs reported she was contacted by a citizen with concerns regarding recycling overflow resulting from the Town's elimination of drop off points, and Councilman Stipes noted he had heard from citizens on this matter, too. At this time, all recycling drop off points have been closed, except for the Christiansburg High School and Home Depot locations. Council discussed leaving the high school site open for citizen use, and adding a corrugated cardboard depository. However, Councilman Showalter recalled Council's decision to close all recycling sites due to abuses by citizens that contaminated recycling materials. Mr. Showalter noted that the high school had been given the option to maintain the drop off point, but turned it down. Councilwoman Sachs noted that Montgomery County Public Schools also turned down the offer to maintain the drop off site. Council agreed to move forward with eliminating the drop off site at Christiansburg High School after the COVID 19 quarantine had been lifted.
- F. Councilwoman Hicks proposed honoring the Christiansburg High School 2020 seniors by reading each student's name during an upcoming council meeting, and thanked the Parks and Recreation staff for the newly created virtual recreation center. She then thanked essential workers and Feeding America for its recent program in Christiansburg, and welcomed them back.
- G. Mayor Barber commended essential workers and first responders for their commitment to the health and welfare of the community and reported on spring clean-up.

ITEM HISTORY:

This area was identified in the “Christiansburg Interceptor Study” as the sewershed with the highest normalized I & I in the entire system. The area also has a high potential for future growth such that identifying and correcting the issues in the sewershed is critical to future development. This area was not identified in the Town’s Letter of Agreement (LOA) with the Virginia Department of Environmental Quality (DEQ), however, with the knowledge that this area is extremely problematic, it is prudent to be proactive and take corrective action prior to any enforcement action by DEQ.
