A REGULAR MEETING OF THE CHRISTIANSBURG TOWN COUNCIL WAS HELD AT CHRISTIANSBURG TOWN HALL, 100 EAST MAIN STREET, CHRISTIANSBURG, VIRGINIA, ON JANUARY 10, 2023, AT 7:00 P.M.

REGULAR MEETING

I. CALL TO ORDER

The Pledge of Allegiance was led by Councilman Wilson.

II. ADJUSTMENT OF THE AGENDA

Mayor Barber made an adjustment to the agenda concerning item C. under Discussion and Action by Council and explained that the certification for Fire Officers would take place in July 2023. Mr. Barber added that the appointment of a representative to the Virginia Tech/Montgomery Regional Airport Authority Board under Other Business, item 6., (f.) would not be needed since the appointments are not ending this year.

Councilman Showalter made a motion to adjust the agenda as proposed, seconded by Councilwoman Hockett. Town Council voted as follows: Bishop – Aye; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – Aye; Wilson – Aye.

III. PUBLIC HEARINGS

A. Rezoning request by Town of Christiansburg, property owner, to rezone property located at the intersection of Peppers Ferry Road, N.W. and Booker T. Washington Parkway, N.W. (under construction) (Tax Parcel 435 – ((A)) – 3A, Parcel ID 270079), commonly known as "Christiansburg Huckleberry Park", an approximately 50.539-acre portion from A Agricultural District to R-1 Single-Family Residential District and an approximately 12.25-

acre portion of the same property from A Agricultural District to B-3 General Business District. The property is designated as Business/Commercial and Parks/Open Space on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan.

The public hearing was opened. With no speakers on the item, the public hearing was closed.

Councilman Bishop made a motion to approve the consent agenda as presented, seconded by Councilwoman Hockett. Town Council voted as follows: Councilman Bishop – Aye; Councilwoman Hicks – Aye; Councilwoman Hockett – Aye; Councilman Jenkins – Aye; Councilman Showalter – Aye; Councilman Wilson – Aye.

V. INTRODUCTIONS AND PRESENTATIONS

- A. Roanoke Regional Small Business Development Center Director (RRSBDC) Amanda Forrester and New River Valley Advisor Leo Priddy to present on the SBDC programs and operations

Amanda Forrester addressed Council and introduced Leo Priddy, New River Valley Advisor and further explained the role of the Roanoke Regional Small Business Development Center. Ms. Forrester expressed that the center's goal was to provide small business owners with skills to operate and grow their businesses. Ms. Forrester noted that 65 businesses within Christiansburg had been advised from January 1, 2022 to December 31, 2022 and out of those 65 businesses 51% were female owned, with 14% minority, and 6% veteran owned. She added that food services, health care, retail, and construction businesses were a few of the many types of businesses they advised. Ms. Forrester explained that the center specialized in business planning, finances, business start-up, marketing, and disaster recovery and expressed that there were statewide trainings that small businesses could attend as well. She explained that most training events were now virtual and easily attended. Ms. Forrester noted the ways to connect with the development center and the many worksheets available online for business owners to grow their businesses. She added that an advisory match on the website was now a new section that business owners could complete and connect with a chosen advisor with knowledge and experience in their line of business. Ms. Forrester thanked Council for investing in their services and helping impact and build the community.

Councilman Bishop inquired if there was an office in the Christiansburg area. Ms. Forrester explained there was an office at the Virginia Tech Corporate Research Center but that the advisors could meet in person anywhere in the area.

Councilman Wilson asked if the Town would have access to the names of clients to be able to support the business owners in the area. Ms. Forrester explained that their work is confidential, and names are not made public. There can be times when they ask permission and added that often clients themselves share their own experiences on the RRSBDC social media platforms.

Councilwoman Hicks asked about the minority statistics referred to earlier in her presentation. Ms. Forrester explained that the individuals self-identify and that her staff does not do make the determination. She added that many choose not to self-report. She ended saying that the Small Business Administration's focus has always been on women, minorities, and the veteran population so they make efforts to make sure that these services are in their hands to access.

VIII. DISCUSSION AND ACTION BY MAYOR AND COUNCIL

- A. Appointment of Alessandro Pugliese of Sandro's Pizzeria as Restaurant Representative to the Montgomery – Blacksburg – Christiansburg Tourism Development Council for a two-year term from January 1, 2023 to December 31, 2024

Councilman Showalter expressed that he would like Mr. Pugliese to attend an upcoming Council meeting and introduce himself.

Councilman Showalter made a motion to approve the appointment of Alessandro Pugliese to the Montgomery – Blacksburg – Christiansburg Tourism Development Council, seconded by Councilwoman Hicks. Town Council voted as follows: Bishop – Aye; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – Aye; Wilson – Aye.

- B. Reappointment of Heather Browning to the Public Arts Advisory Board for a two-year term from January 1, 2023 to December 31, 2024

Mayor Barber noted that Ms. Browning had reached out to him and expressed interest in coming before Council but was unable this week.

Councilman Jenkins made a motion to reappoint Heather Browning to the Public Arts Advisory Board, seconded by Councilwoman Hicks. Town Council voted as follows: Bishop – Aye; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – Aye; Wilson – Aye.

D. Agreement for Use of the Christiansburg Aquatic Center with Radford City

Aquatics Director Terry Caldwell explained that one of the changes to the agreement with Radford City was a small fee increase. Councilwoman Hicks voiced appreciation for bringing this item to Council and expressed that the citizens of Christiansburg and Radford should be paying an equivalent fee to use the Aquatic Center.

Councilman Showalter made a motion to approve the agreement for Use of the Christiansburg Aquatic Center with Radford City, seconded by Councilman Wilson. Town Council voted as follows: Bishop – Aye; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – Aye; Wilson – Aye.

E. Town funding of school resource officers in Montgomery County Public Schools (Showalter and Hockett)

Mayor Barber noted that the Town had asked Montgomery County to reimburse the Town \$265,000 a year for funding for school resource officers and the request had been denied. Mr. Barber explained that several Councilmembers had desired to bring the subject back to the table for discussion.

Councilman Showalter explained the history of the funding of resource officers and noted that early on the Christiansburg Police Department had located grants from the state to fund officers in schools. Mr. Showalter further explained that not all Montgomery County Schools had officers and noted that the County had decided to fund Montgomery County Schools in the unincorporated areas only. Mr. Showalter added that he felt since Christiansburg citizens are paying both County and Town taxes, and the County has decided to fund the positions in the unincorporated areas, then the County should fund both the in-Town and out-of-Town schools.

Councilman Jenkins inquired what will take place if the County continues to refuse assistance with funding. Mayor Barber recommended to Council that he draft a letter to send to the Board of Supervisors, the County Administrator, and the School Board Members informing them of Council's action. Mr. Barber explained that the Town should no longer fund the resource officers without the County's help. He added that Christiansburg citizens that live in corporate limits pay County taxes as well and felt that this was not a huge ask as opposed to the taxes the citizens are paying. Councilman Showalter communicated that there would be more discussion within Council if the County denied funding, which would be before officers were permanently removed from the schools.

Mayor Barber added that in his initial letter to Montgomery County he had asked the County to consider including the Town of Blacksburg in their decision as well. Councilwoman Hicks expressed that the Town was not asking for an enormous amount of money for officers in the schools and noted her appreciation to the Christiansburg Police Department for their involvement pertaining to the officers in the past years.

Councilman Showalter reminded Council of the Christiansburg's previous Park and Ride location near Falling Branch Elementary School and the dilemma of transients using the school's facilities. Mr. Showalter noted the County's resistance to the Town being involved with their public schools at that time. Mr. Showalter explained that Council owes it to the citizens to be fiscal-minded and to place a motion on the table and added that he will support it.

Councilman Bishop expressed that all schools should have resource officers and would prefer the County to help fund those officers in the Town but is concerned about pulling the officers out of the schools. Mayor Barber expressed that it takes an ending statement and date if the Town is going to do it, and that is what would be proposed. Mr. Barber added that if the Town of Christiansburg should pull resource officers out of schools that does not violate any legal requirements and that he spoke to both the Town Manager and Town Attorney for confirmation of this. Mayor Barber added that the Christiansburg Police Department would still respond if there was an issue at the schools. Councilwoman Hicks expressed that she has children in the schools in Town and has always considered the children and the officers very important.

Councilwoman Hockett expressed that she was disappointed that the County would not support the schools within the Town. Mrs. Hockett also noted her concern about pulling the resource officers from the schools and expressed that many students feel comfortable and safe with the current officers and there have been important connections made. She asked if there is anything else that could be done to further this conversation. Councilman Jenkins agreed that every school should have resource officers but also expressed that Montgomery County should help in funding those officers.

Councilman Wilson made a motion to suspend funding for school resource officers as of July 1, 2023, seconded by Councilwoman Hicks. Town Council voted as follows: Bishop – Nay; Hicks – Aye; Hockett – Nay; Jenkins – Nay; Showalter – Aye; Councilman Wilson – Aye.

Due to a divided vote of Council, Mayor Barber voted in favor of the motion to suspend funding for school resource officers beginning July 1, 2023. The motion passed.

IX. STAFF REPORTS

A. Town Manager

Town Manager Randy Wingfield reminded Council that the annual disclosure forms were due by February 1, 2023. Mr. Wingfield asked Council if they would like to schedule a work session in the upcoming weeks for a training on COIA (Conflict of Interest Act) and FOIA (Freedom of Information Act). Town Attorney Reid Broughton explained this training would take up to an hour. Council agreed to a 5:30 p.m. Street Committee Meeting and a 6:00 p.m. training for COIA and FOIA led by the Town Attorney, on January 24th.

XI. OTHER BUSINESS

A. Re-organization for the Year 2023:

1. Town Council election of Vice-Mayor

Councilwoman Hicks expressed interest in the position of Vice-Mayor and made a motion to nominate herself. For a lack of a second, the motion failed.

Councilman Wilson made a motion to elect Councilman Bishop as Vice-Mayor, seconded by Councilman Showalter. Town Council voted as follows: Bishop – Abstain; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – Aye; Wilson – Aye.

2. Town Council to set regular meeting dates and times of Council

Councilwoman Hicks suggested moving the Town Council meeting times to 6:00 p.m. Mayor Barber commented that the times prior to Council meetings are typically used for committee meetings. Councilman Showalter noted that the Council meeting time has been addressed in the past, but the other meetings scheduled prior interfere with an earlier start time.

Councilman Bishop made a motion to keep the regular meeting dates and times of Council moving forward, seconded by Councilman Wilson. Town Council voted as follows: Bishop – Aye; Hicks – Aye; Hockett – Aye; Jenkins – Aye; Showalter – aye; Wilson – Aye.

3. Mayor appointment of Town Council Committees:

a. Water and Waste Committee

Mayor Barber appointed Councilwoman Hicks and Councilman Wilson to the Water and Waste Committee.

b. Street Committee

Mayor Barber appointed Councilwoman Hockett and Councilman Bishop to the Street Committee.

- c. Finance Committee
Mayor Barber appointed Councilman Showalter and Councilman Bishop to the Finance Committee.
- d. Emergency Services Committee
Mayor Barber appointed Councilwoman Hockett and Councilman Wilson to the Emergency Services Committee.
- e. Central Business District Committee
Mayor Barber appointed Councilwoman Hicks and himself to the Central Business District Committee.

Councilwoman Hicks expressed that being appointed to this position was a positive appointment but could also be a disadvantage for a Town Council business owner. Mrs. Hicks noted that she would like to refuse the appointment to the Central Business District Committee.

Councilman Showalter asked Councilman Jenkins why he did not want to be on the committee because he felt that both Mr. Jenkins and Mrs. Hicks would be best to represent the committee because of their backgrounds.

Councilman Jenkins expressed that scheduling was a conflict for him due to the meetings being held in the middle of the day and expressed adverse negative affects with his full-time role at the Montgomery Museum. Mr. Jenkins added that he would prefer to offer his knowledge elsewhere.

Councilwoman Hicks commented that the time of the meetings could be changed. She expressed concern over the 12:00 p.m. meetings and stated that since she works during the day it would be difficult for her to attend.

Mayor Barber stated that the Central Business meetings could be moved to accommodate the members and added that monthly meetings could be moved to quarterly meetings.

After discussion by Council, Councilwoman Hicks and Councilman Jenkins agreed to remain on the Central Business District Committee. Mayor Barber appointed Mr. Jenkins as Chair.

ITEM TITLE:

Rezoning request by Town of Christiansburg, property owner, to rezone an approximately 50.539-acre portion of the property located on Booker T. Washington Parkway, NW (Tax Parcel 435 - ((A)) – 3A, Parcel ID 270079) commonly known as “Christiansburg Huckleberry Park”, from A Agricultural District to R-1 Single-Family Residential District and an approximately 12.2-acre portion of the same property from A Agricultural District to B-3 General Business District. The property is designated as Business/Commercial and Parks/Open Space on the Future Land Use Map of the 2013 Christiansburg Comprehensive Plan. The public hearing was held January 10, 2023.

DESCRIPTION:

The purpose of this request is to change the zoning for the park into something more appropriate than the A Agricultural District, and more in-line with the surrounding zoning in consideration of good planning practice. The property will still be developed according to the “Master Plan” for the park, and the use of the property as a park will not change.

The Zoning Ordinance states that agriculturally zoned land is intended to transition to other zoning classifications once non-agricultural uses are found for it. Since the property is no longer being used for agriculture, it should therefore be rezoned to something else.

The proposed zoning is for approximately 50.539 acres of R-1 Single-Family Residential, and 12.25 acres of B-3 General Business. The portions proposed to be B-3 lie on the eastern side of the park and abut other property along North Franklin Street, Bradley Drive, and Peppers Ferry Road which is also zoned B-3. The remainder of the park is proposed to be zoned R-1 Single-Family Residential. This is the same zoning as the residential properties to the west and south and is the lowest intensity zoning district available which is not agricultural.

On November 28, 2022, Planning Commission voted 6 to 0 to recommended to approval of the request.

Assignment of Terms for New River Valley Passenger Rail Station Authority

DESCRIPTION:

The New River Valley Passenger Rail Station Authority ([Code of Virginia Code - Chapter 38. New River Valley Passenger Rail Station Authority](#)) has been established for the purpose of development, ownership, and operation of a passenger rail station. The Virginia Passenger Rail Authority has narrowed the location to a general area north of Uptown Christiansburg (formerly the NRV Mall) for the site of the station and is preparing site and building plans for the construction. Town Council acted to participate in the New River Valley Passenger Rail Station Authority at its October 12, 2021 meeting.

The initial members of the Authority are Giles County, Montgomery County, Pulaski County, Radford City, the Towns of Blacksburg, Christiansburg and Pulaski, Virginia Tech, and Radford University. Each member has two representatives to the Board, but voting will be weighted based on financial contributions to the Authority. The organizational documents for the authority do not prescribe whether the representatives need to be an elected official, that distinction is up to the governing body making the appointment. Per the state code, appointees shall be residents of the jurisdiction making the appointment.

On August 9, 2022, Town Council voted to appoint Mayor Barber and Town Manager Wingfield to the Board of Directors for the New River Valley Passenger Rail Station Authority, and the Secretary of the Commonwealth certified the terms of all Board members as beginning September 1, 2022. The Board of Directors has begun meeting and all members have been asked to now designate their representatives as having an initial term of either two or four years, to initiate staggered terms, as detailed in Code of Virginia § 33.2-3803 (<https://law.lis.virginia.gov/vacode/title33.2/chapter38/section33.2-3803/>). The length of terms will be four years in the future after this action to stagger the terms. Mayor Barber and Town Manager Wingfield suggest that Town Council designate Mayor Barber as the four-year term and Mr. Wingfield as the two-year term.
