Project Type: Construction

Title: Church, Righy, Ellett Storm Drainage Improvements

Total Estimated Project Cost: \$1,000,000

Requested State Matching Funds: \$500,000

Project Description: Installation of storm drainage piping and inlets from Church Street to Ellet Road. Project addresses flooding of properties and streets.

Project Priority No. 2

Project Type: Construction

Title: Park Street Sidewalk and Drainage Improvements

Total Estimated Project Cost: \$301,000

Requested State Matching Funds: \$150,500

Project Description: Installation of storm drainage piping and inlets in conjunction with curb, gutter and sidewalk improvements on Park Street from Depot Street to East Street. Project addresses street flooding and improves pedestrian access.

Project Priority No. 3

Project Type: Construction

Title: Huckleberry Trail (Trail) Phase III Extension

Total Estimated Project Cost: \$899,633

Requested State Matching Funds for Construction: \$449,816

Project Description: Continuation of the trail system from Phase IID of the Trail through Christiansburg High School, connecting to the existing sidewalk at the intersection of North Franklin Street and Independence Boulevard. Improvements include paved trail with curb, gutter, storm drainage improvements and paving for the Independence Blvd. turn lane extension on N. Franklin Street.

Project Priority No. 4

Project Type: Construction

Title: Hans Meadow Drive Drainage Improvements

Total Estimated Project Cost: \$1,092,500

Requested State Matching Funds for Construction: \$546,250

Project Description: Installation of storm drainage piping and inlets on Hans Meadow Drive from Robin Hood Drive to Sherwood Drive. Project addresses flooding of properties and streets.

Project Priority No. 5

Project Type: Maintenance

Title: Pavement Maintenance (Overlay)

Total Estimated Project Cost: \$800,000

Requested State Matching Funds for Construction: \$400,000


Project Description: Pavement overlay of Town streets meeting the criteria for funding coverage under the Revenue Sharing Program (town wide).


