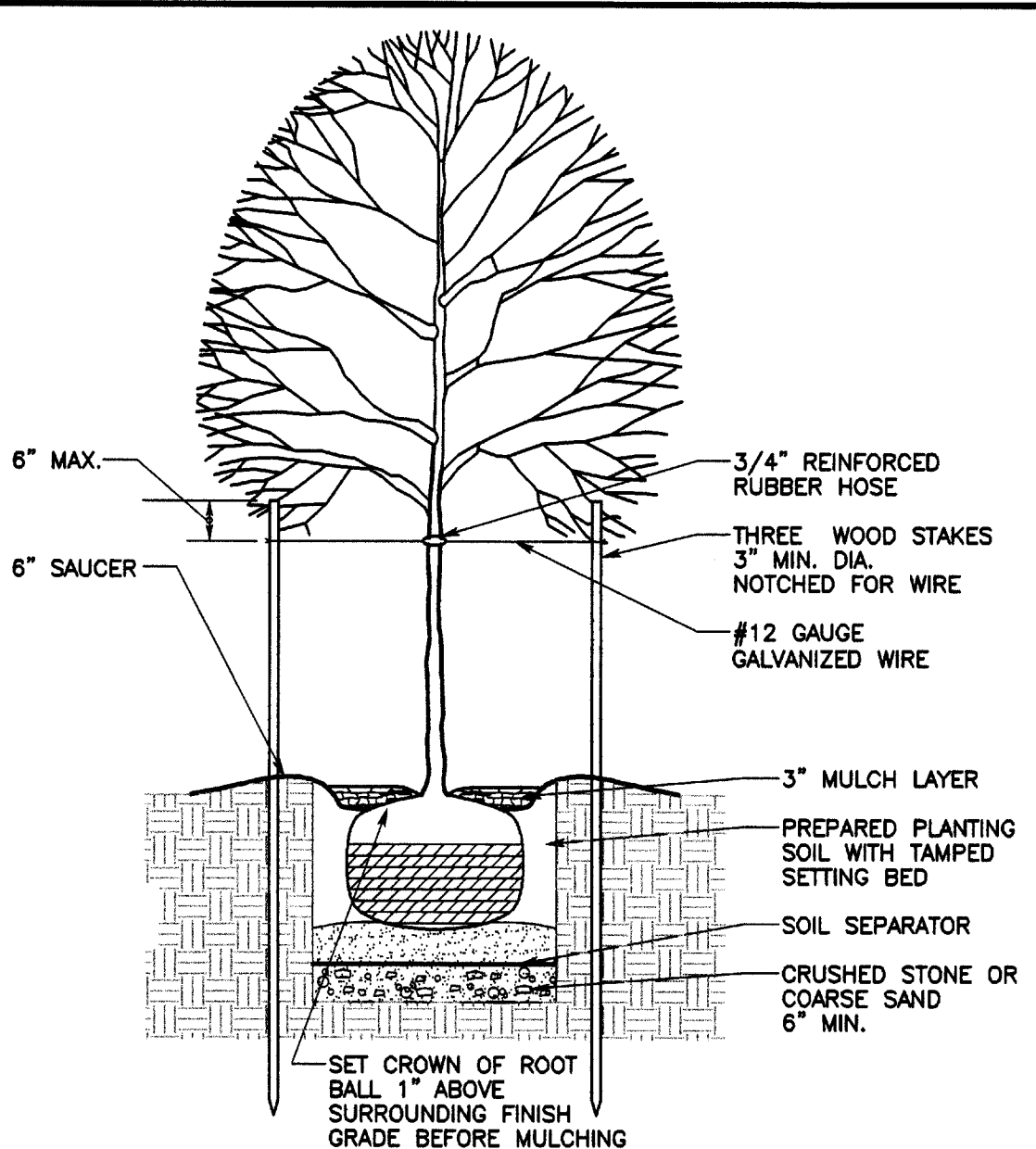


VICINITY MAP

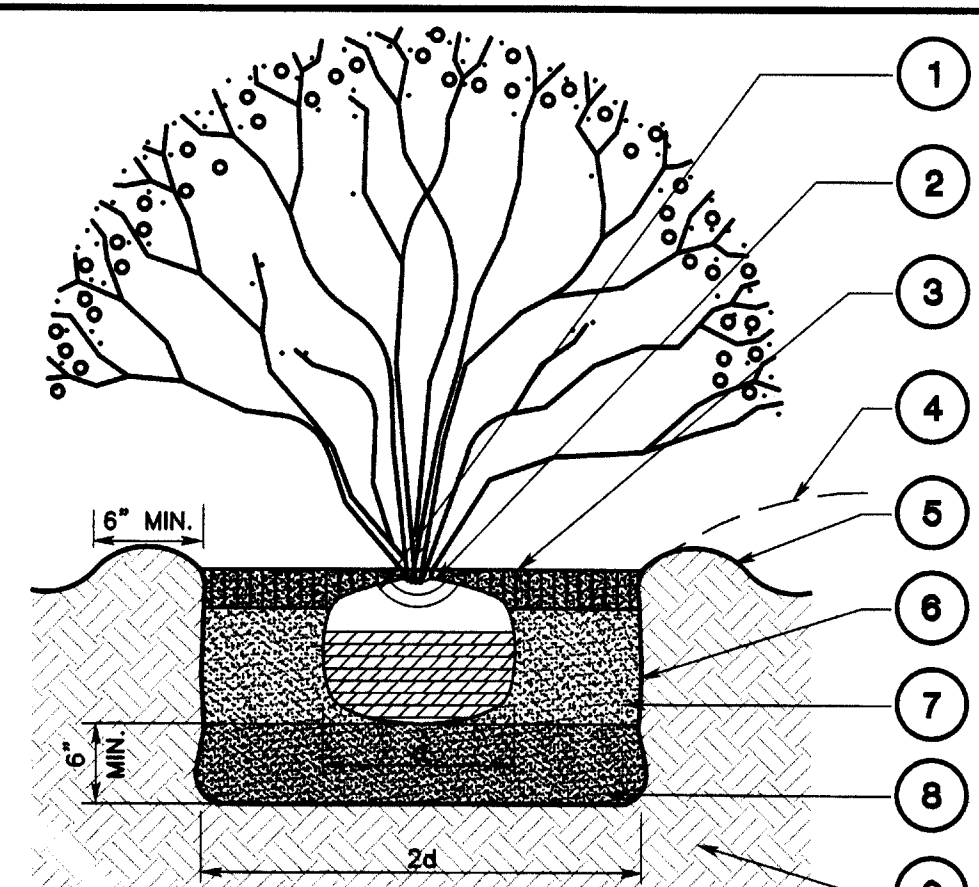
TREE PLANTING

LANDSCAPE NOTES:

- ALL TREES AND SHRUBS TO BE PLANTED SHALL MEET THE PROJECT SPECIFICATIONS.
- ALL TREE AND GROUND COVER PLANTING, SEEDING OR GRASSES, AND TREE STAKING SHALL BE IN ACCORDANCE WITH THE STANDARDIZED LANDSCAPE SPECIFICATIONS JOINTLY ADOPTED BY THE VIRGINIA NURSERYMEN'S ASSOCIATION, THE VIRGINIA CHAPTER OF THE AMERICAN SOCIETY OF LANDSCAPE ARCHITECTS, THE VIRGINIA SOCIETY OF LANDSCAPE DESIGNERS AND THE VIRGINIA NURSERYMEN'S ASSOCIATION, OR THE ROAD AND BRIDGE SPECIFICATIONS OF THE VIRGINIA DEPARTMENT OF TRANSPORTATION.
- HANDLING AND STORAGE OF ALL PLANT MATERIALS ON THE CONSTRUCTION SITE SHALL BE CONDUCTED IN ACCORDANCE WITH THE AMERICAN STANDARD FOR NURSERY STOCK AND THE ABOVE CITED SPECIFICATIONS.
- ALL SITE PLANTINGS OF TREES AND SHRUBS SHALL BE ALLOWED TO REACH, AND BE MAINTAINED AT, MATURE HEIGHT; THE TOPPING OF TREES IS PROHIBITED; SHRUBS SHALL BE PRUNED MINIMALLY AND ONLY TO SUPPORT THE OVERALL HEALTH OF THE SHRUB.
- NO PLANT SUBSTITUTIONS WITHOUT THE APPROVAL OF THE LANDSCAPE ARCHITECT.
- TREE PROTECTION FENCING WILL BE INSTALLED ALONG LIMITS OF CLEARING. FENCING SHALL BE 40" HEIGHT 'INTERNATIONAL ORANGE' PLASTIC WEB FENCING.
- ALL SEEDING AND PLANTING SHALL BE DONE BETWEEN AUGUST 15 AND OCTOBER 15, OR ALTERNATIVELY BETWEEN MARCH 15 AND MAY 1. SEEDING OR PLANTING AT OTHER DATES WILL BE SUBJECT TO APPROVAL BY THE LANDSCAPE ARCHITECT AND MAY REQUIRE SPECIAL PROCEDURES.
- TREES DEPICTED HEREON ARE SHOWN WITH 20 YEAR CANOPY SPREAD.
- DESIGNATED AREA TO BE SEED WITH A LOW MAINTENANCE SLOPE MIXTURE CONSISTING OF AND APPLIED AT THE FOLLOWING RATE PER ACRE:
 - KENTUCKY 31 FESCUE 108 LBS
 - RED TOP GRASS 2 LBS
 - SEASONAL NURSE CROP 20 LBS
 - CROWNVEITCH (INOCULATED) 20 LBS
- ALL PLANTING INSTALLATION SHALL BE IN ACCORDANCE WITH THE GUIDELINES SET FORTH BY THE AMERICAN NURSERY & LANDSCAPE ASSOCIATION AND AMERICAN STANDARD FOR NURSERY STOCK (ANSI Z60.1-2004).
- ALL TREES AND SHRUBS SHALL BE NURSERY GROWN AND SHALL CONFORM TO THE REQUIREMENTS OF ANSI Z601-1996. PLANTING STOCK SHALL BE WELL-BRANCHED, SYSTEMATICALLY DEVELOPED WITH A SINGLE LEADER (EXCEPT WHERE CALLED OUT), AND FREE FROM DISEASE, SUN-SCALD AND HARMFUL INSECTS.
- NO EDGING, METAL OR BRICK SHALL BE USED. INSTEAD THE CONTRACTOR WILL BE REQUIRED TO 'CUT IN' THE EDGE, FORMING A CLEAN TRANSITION BETWEEN TURF AND BED.
- ALL OF THE CLUSTER PLANTINGS SHALL BE MULCHED TOGETHER.
- PERFORM OPERATIONS WITHIN THE FOLLOWING DATES: FROM 01 MARCH TO 15 JUNE FOR SPRING AND FROM 15 SEPTEMBER TO 30 NOVEMBER FOR FALL.
- NO WORK SHALL BE DONE WHEN GROUND IS FROZEN, SNOW COVERED, TOO WET OR IN AN OTHERWISE UNSUITABLE CONDITION FOR PLANTING. SPECIAL CONDITIONS MAY EXIST THAT WARRANT A VARIANCE IN THE SPECIFIED PLANTING DATES OR CONDITIONS.

VDOT GENERAL NOTES:

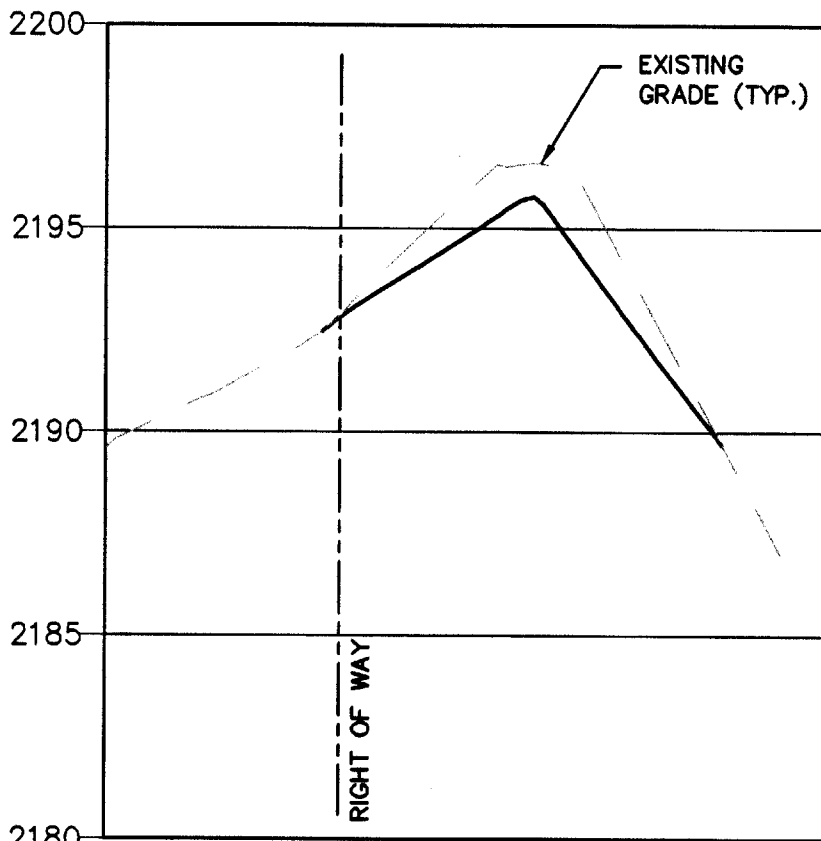
- ALL MATERIALS AND CONSTRUCTION WITHIN THE I-81 RIGHT-OF-WAY SHALL BE IN ACCORDANCE WITH CURRENT VIRGINIA DEPARTMENT OF TRANSPORTATION'S STANDARDS AND SPECIFICATIONS.
- LAND USE PERMITS MUST BE OBTAINED FROM THE VIRGINIA DEPARTMENT OF TRANSPORTATION PRIOR TO BEGINNING ANY CONSTRUCTION WITHIN THE EXISTING STATE MAINTAINED RIGHT-OF-WAY (INCLUDING ACCESS).
- ALL WORK SHALL BE COORDINATED WITH THE VDOT PERMITS OFFICE TWO WEEKS PRIOR TO COMMENCING WITH INITIAL CONSTRUCTION. CALL 1-800-FOR-ROAD FOR MORE INFORMATION.
- CONTRACTOR SHALL VERIFY LOCATION AND ELEVATION OF ALL UNDERGROUND UTILITIES SHOWN ON PLANS IN AREAS OF CONSTRUCTION PRIOR TO STARTING WORK. CONTACT ENGINEER IMMEDIATELY IF LOCATION OR ELEVATION IS DIFFERENT FROM THAT SHOWN ON PLAN. IF THERE APPEARS TO BE A CONFLICT, AND/OR UPON DISCOVERY OF ANY UTILITY SHOWN ON THIS PLAN, CALL MISS UTILITY. THE DEVELOPER SHALL BE RESPONSIBLE FOR THE RELOCATION OF ANY UTILITY WITHIN EXISTING AND/OR PROPOSED RIGHT-OF-WAY REQUIRED BY THE DEVELOPMENT.
- ALL VEGETATION AND ORGANIC MATERIAL IS TO BE REMOVED FROM THE RIGHT-OF-WAY LIMITS PRIOR TO CONDITIONING OF THE SUBGRADE.
- THE LANDSCAPE AND GRADED AREAS WITHIN THE VDOT RIGHT-OF-WAY SHALL MAINTAIN A MINIMUM OF 3% SLOPE TOWARDS THE EXISTING DITCHLINE OF I-81 AND THE PROPOSED PARKING AREA OF THE SHELOR DODGE DEALERSHIP. EXISTING FLOW PATTERNS SHALL BE MAINTAINED.



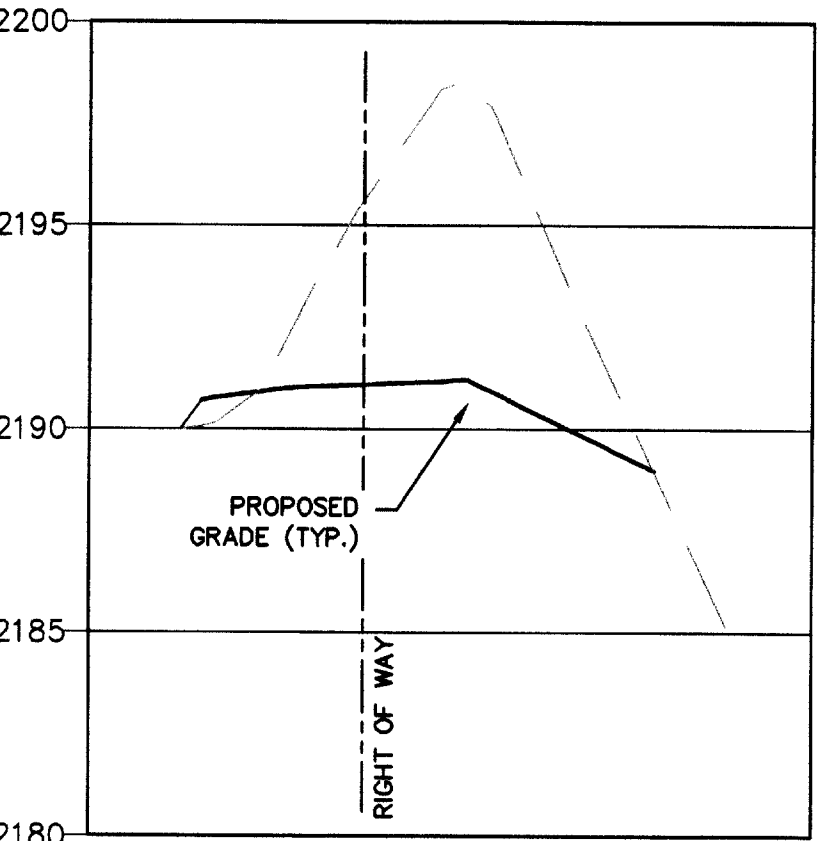
SHRUB PLANTING

NOTES:

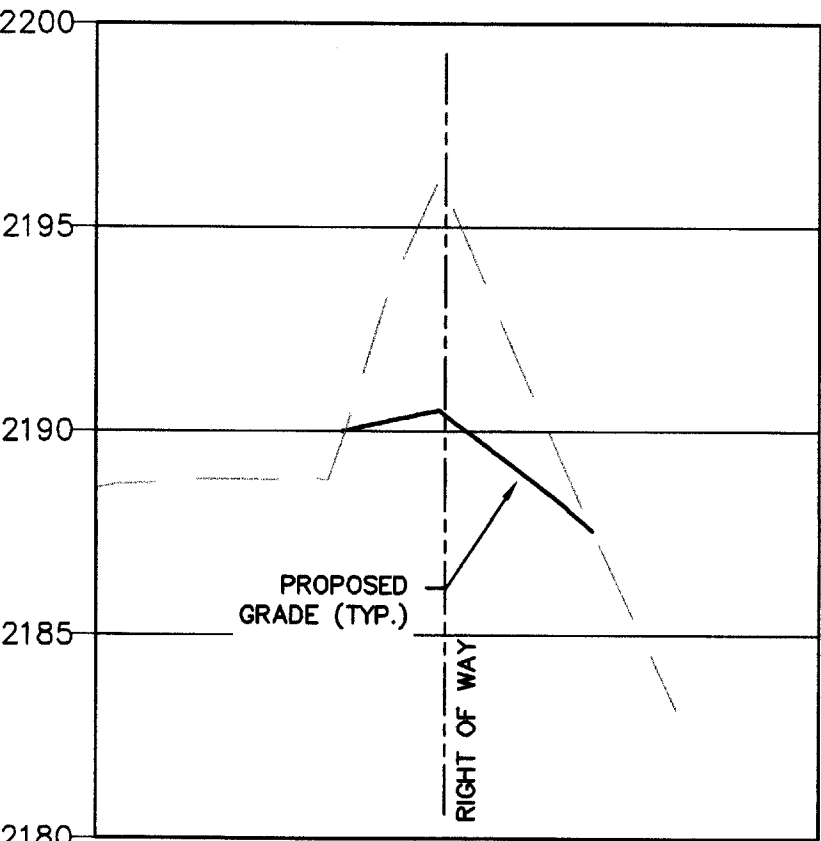
- REMOVE PLANT FROM CONTAINER OR WITH B & B MATERIAL PEEL BACK BURLAP AND REMOVE WIRE FROM ROOTBALL AFTER 3/4 BURIED IN PIT.
- PLANT CROWN AT 1" ABOVE FINISH GRADE
- MULCH-3" DEPTH.
- EASE BACK SLOPE ON UPHILL SIDE WHERE APPLICABLE.
- 3" HIGH WATERING RING EXCEPT AT DRIP IRRIGATED AREAS OR IN PLANTBEDS.
- SCARIFY SIDES OF HOLES PRIOR TO PLANTING.
- PLANTING SOIL
- FOOT TAMPED COMPACTED BACKFILL UNDERBALL TO PREVENT SETTLING.
- UNDISTURBED/COMPACTED SUBSOIL.



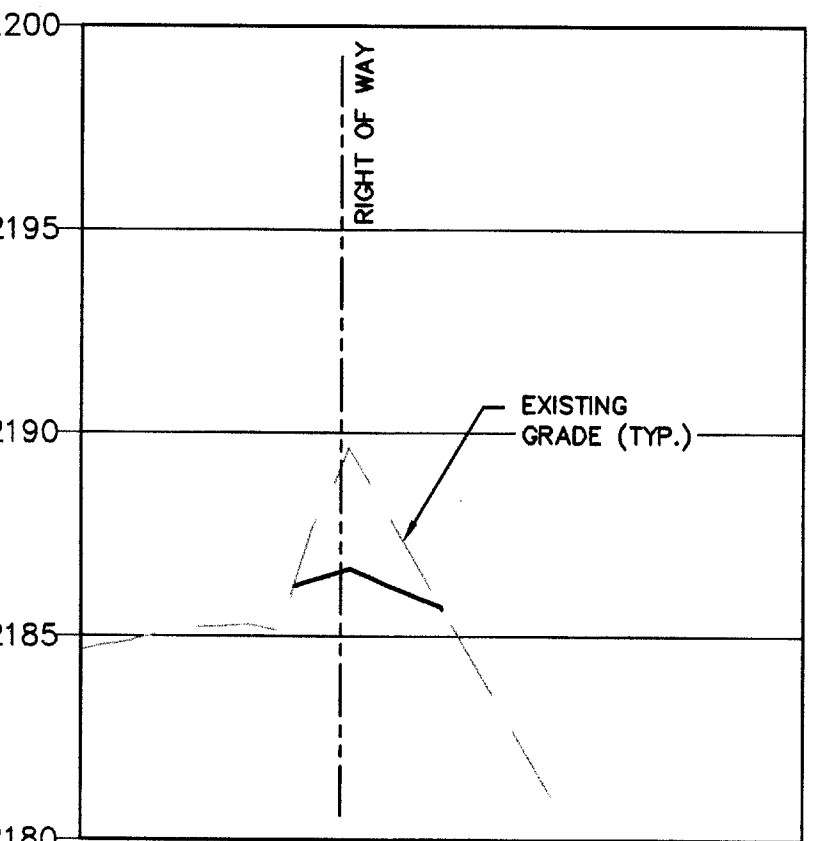
SECTION AA

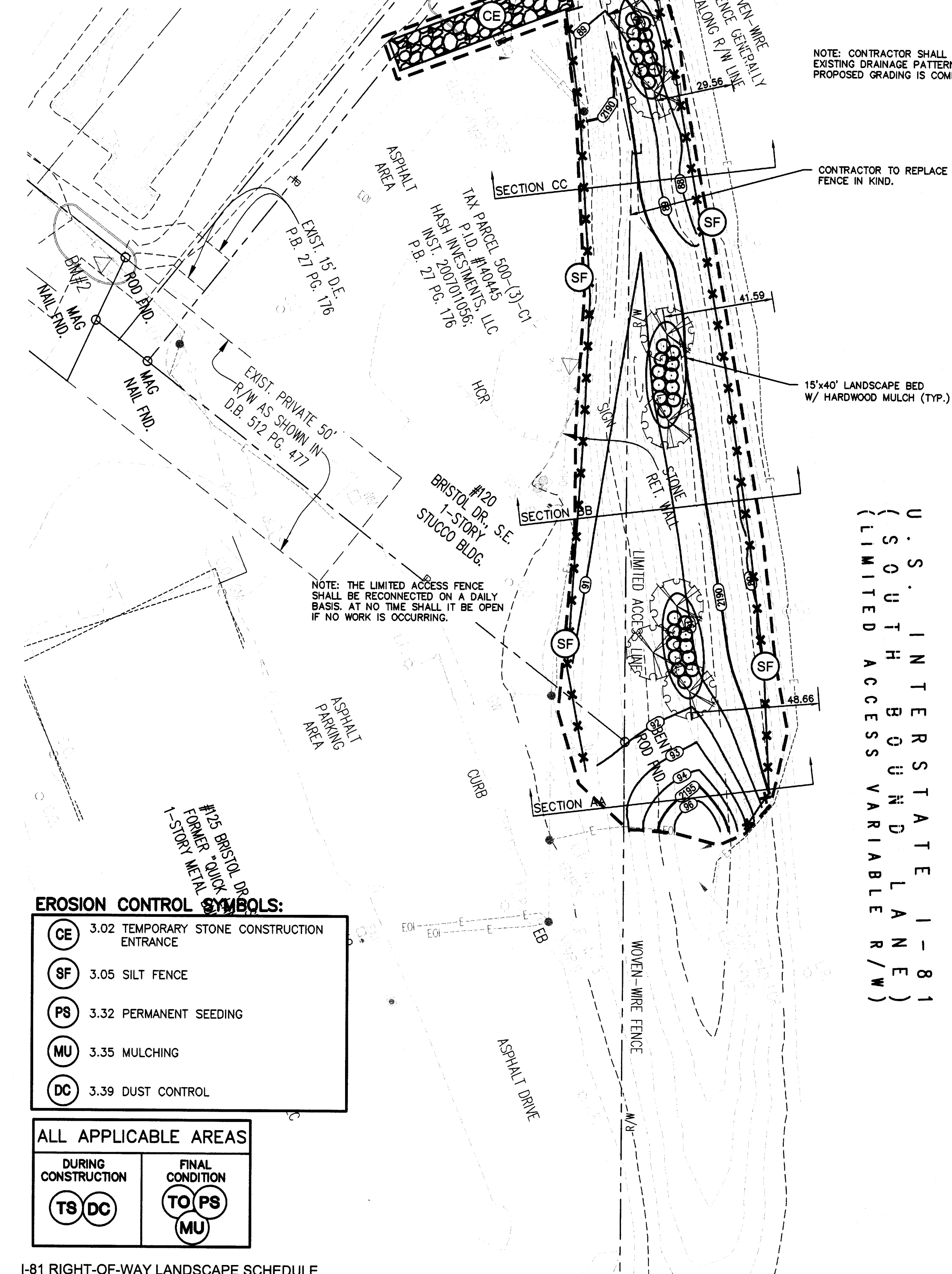
SECTION CC

SEQUENCE OF CONSTRUCTION:

- INSTALL ALL PERIMETER CONTROL MEASURES: CE, SF.
- PERFORM ALL NECESSARY GRADING.
- CONTROLS SHALL BE REMOVED ONLY AFTER PERMANENT STABILIZATION HAS BEEN ACHIEVED, AND RECEIVED APPROVAL BY THE TOWN INSPECTOR.
- FAILURE TO FOLLOW THE SEQUENCE OF CONSTRUCTION OF THE APPROVED PLAN SHALL BE CONSIDERED A VIOLATION AND WILL RESULT IN FURTHER ENFORCEMENT, INCLUDING, BUT NOT LIMITED TO STOP WORK ORDERS AND CIVIL PENALTIES.
- THE CONTRACTOR SHALL INSTALL THE PERIMETER EROSION AND SEDIMENT CONTROL MEASURES PER THE APPROVED PLAN.
- THE CONTRACTOR SHALL CONTACT VDOT FOR A FINAL SITE INSPECTION.

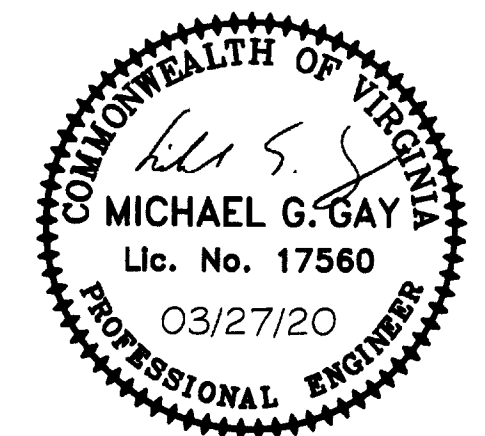
