1. Will play two 20 minute halves, teams may press the last 2 minutes of each half. Teams with a 10 points lead cannot press. Defense cannot be played until the ball has crossed the volleyball line in the front court.
2. Game will consist of a running clock. The last 2 minutes of each half will be a regulation clock, and will stop for fouls, foul shots and out of bounds.
3. Teams will have 2 time outs per half.
4. Overtime Period – 3 minute running clock; the last minute will be a regulation clock. Will stop for fouls, fouls shots and out of bounds. If still tied after overtime period, the game will end in a tie.
5. Teams get 1 time out for overtime. Time outs do not carry over from game regulation.
6. Each player is required to play 8 minutes per half.
7. If schools are cancelled or dismissed early due to inclement weather all games and practices will be postponed.
