


BUS STOP #2227 DEMOLITION PLAN




BUS STOP #2227 SITE LAYOUT PLAN





INSTALLATION NOTES:

- CONTRACTOR SHALL INSTALL CONCRETE PAD AND BUS SHELTER AS SHOWN. THE BUS SHELTER WILL BE PROVIDED TO THE CONTRACTOR BY BLACKSBURG TRANSIT FOR INSTALLATION. THE CONTRACTOR SHALL PROVIDE ALL OTHER MATERIALS. CONTRACTOR SHALL CONFORM TO THE TOLAR MANUFACTURING COMPANY INSTALLATION STANDARDS FOR A 4'x8' NON AD BUS STOP SHELTER "NIAGARA SERIES" WITH REAR AND SIDE GLASS PANELS.
- CONTRACTOR SHALL INSTALL SOLAR PANELS ATOP THE BUS SHELTER TO POWER BT BUS SHELTER LIGHTING. INSTALLATION OF SOLAR PANELS SHALL CONFORM WITH ALL APPLICABLE CODES.
- BUS SHELTER STRUCTURE SHOWN HEREON FOR INFORMATION PURPOSES ONLY. CONTRACTOR SHALL VERIFY DIMENSIONS FOR CORNER POSTS WITH SHELTER MANUFACTURER.
- RELOCATED BT SIGN POST SHALL BE INSTALLED 2' FROM THE EDGE OF PAVEMENT AS SHOWN ON THE SITE LAYOUT.
- PROPOSED TRASH CAN SHALL BE INSTALLED A MINIMUM DISTANCE OF 2' FROM THE PROPOSED SHELTER GLASS.



BUS STOP #2227 GRADING PLAN




